(2) the reduction of issued share capital whereby the par value of each issued Consolidated Share was reduced from HK\$1.25 to HK\$0.25 by cancelling the paid-up capital to the extent of HK\$1.00 on each of the Consolidated Shares to a Reduced Share of HK\$0.25 each; and

(3) the Sub-Division of each unissued Consolidated Share into five Reduced Shares of HK\$0.25 each.
